- A. I hereby certify that all information furnished by me is true, correct, and complete. I have no borrowing arrangements except as indicated in the application form. I have not applied to any other lending institution under the PM SVANidhi scheme. The information submitted herein may be exchanged by you with any agency, you may deem fit. You, your representatives, Lending Institution (LIs) or MoHUA, or any other agency as authorized by you / MoHUA / LI, may at any time, inspect/ verify my/our assets etc. You may take appropriate safeguards/action for recovery of lending institutions' dues.
- B. I understand that by submitting this application form, I am providing my consent for application for loans in 3 cycles. My maximum loan amount in the first cycle will be ₹10,000/. On full repayment of the 1st loan, maximum loan amount will be ₹20,000/- in the 2nd cycle, and after full repayment of 2nd loan; maximum loan amount will be ₹50,000/- in the 3rd cycle. For the purpose of 2nd and 3rd loan, my application will be auto generated after full repayment of previous loan and sent to the lender. I will become eligible for the next cycle of the loan only after full repayment of earlier loan and submission of consent either digitally or manually for the subsequent loans.
- C. I have no objection to authenticate my Aadhaar number, share the same with other Ministries / Departments under the Government of India or the State Government for the purpose of extension of benefits under any of their Schemes, carry out e-KYC and accessing my credit history & credit score from credit bureau by the lenders and their authorized agents. The consent and purpose of collecting Aadhaar has been explained to me in local language. MoHUA/Lending Institution has informed me that my Aadhaar submitted herewith shall not be used for any purpose other than mentioned above, or as per requirements of law. I have been informed that this consent and my Aadhaar will be stored along with my account details with MoHUA or their authorised agent as per the extant law.
